# **CAPITAL PUNISHMENT THE LAW OF PENAL SYMMETRY**

## **Sample – Chapter 1: THE SUPREME LAW: HE WHO KILLS, DIES**

In Xion there is no room for sentimentality disguised as law. In this civilization, rules do not exist to console emotions, but to repair balance when a destructive action has broken it. The most important rule, the one that governs the gravest act, is simple, known by all, and allows no interpretation: if you take a life, you lose your own.

There are no exceptions. It does not matter if a person was the victim of a painful childhood, if they lived

surrounded by hardship, or if their emotions were conditioned from an early age. In Xion, all its inhabitants recognize a fundamental truth: society is a system that is already in operation, and it cannot be restarted from zero to adapt to each individual's personal history. No one can demand to be born in a perfect environment. Justice, to be functional, must act on the decisions made within the system that exists, not on an ideal system that should have been.
