

THE PREEEXISTENCE OF KNOWLEDGE

Humanity often confuses discovery with invention.

We claim authorship over mathematics, physics, and logic, as if knowledge originates within us.

This book challenges that assumption. It proposes that knowledge is not created but revealed: a preexisting structure of the cosmos that existed long before us and will persist long after.

We are biological receivers—imprecise and limited ones. The book ends with a warning: gaining access to the

universe's codes without overcoming our tribal instincts is not progress, but a direct path to systemic collapse.

The most deeply rooted—and the most mistaken—idea about knowledge is that it is born in the human mind. We have grown used to thinking that the universe was a mass of silent matter and energy, and that only when a consciousness appeared capable of observing it, asking questions, and formulating answers, this knowledge began to exist. This vision, where the human being is the protagonist who illuminates a dark cosmos, is comfortable and flattering, but it is wrong. The truth is simpler and completely displaces us from the

center. The universe and knowledge are not two separate entities that met at some point in history. They are the same concepts. They have always existed together, because one is the expression of the other.
